As you prepare for October's meeting please take a look at the September Meeting Minutes and the October Treasurer's Report. Also, you will see the same bylaw proposal that was in the September Newsletter.

Proposed bylaw change

Article V Section 1: Duties of the President shall include:

Add new language to the end of the list. After: *Request a Nominating Committee of at least three members no later than the March Meeting.*

Insert: *Be a co-signer to the Guild bank account to facilitate monthly spot checks comparing the Treasurer Reports with the monthly bank statements.*

The purpose of this change is to add a second person to look at the finances of the Guild. This in no way is meant to cast any aspersions on Deb's long and faithful work for us all. Instead, it is meant to bring the operation of the Guild more into compliance with standard accounting practices.

I hope you will vote to approve this change along with the September Minutes and the October Treasurer's Report

The Fundraising Committee - Jean Ann Branch, Linda Nadeau and Nanc Ekiert – have already gotten a jump on this year's fundraising efforts and they have a role for all of us to play. They will bring a list of businesses they plan to solicit and solicitation letters as well to the October Meeting. Franklin County Quilters Guild Minutes September 19, 2019

Members Present: 48-- 6 of whom were new members

Guests: 9

The meeting began with an Ice Cream Social followed with a program about **Barn Quilts** by **Suzi Parron**.

The minutes of the June meeting and September financial statement were approved on a motion by Dale McFeeters, seconded by Becky Mandeville.

2019 Charity Quilt was awarded to the Connor Roberts Foundation. Denise Chase volunteered to make the quilt.

Bylaw Changes: A change to the By Laws has been proposed to add the Guild President to the bank statements and as a co-signer for checks.

Program: Krissy Kilburn announced that the Guild will no longer be giving fat quarters for people's birthdays or have a prize drawing for Charity Quilts. These changes were decided at the Executive Committee meeting in August. Members who attend meetings will sign in by number. A number will be drawn at the end of the meeting and matched to the sign in number. The winner will draw a prize which will be a \$25 gift certificate to a quilt related business. By eliminating the fat quarters and prize for Charity Quilts, money was made available for the \$25 gift cards.

Mary King will do a workshop for members who want to make their own barn quilts on October 20th. Information on what supplies will be needed will be sent out to the membership prior to the workshop.

Library: A selection of books will be available at meetings for members to borrow.

Donation: Mary King has donated a barn quilt to the Guild to raffle off to benefit programs. It will be decided at a later date about the timing and how the raffle will take place.

Comfort Quilts: No Guild member/s volunteered to take on the Home Health quilts. Therefore the Executive Committee has changed the name of Charity Quilts to *Comfort Quilts*. This takes away the stigma the word 'charity' has. Breast Cancer has a surplus of quilts. Fire and Other Disaster has many smaller quilts when the demand is for full or queen sized quilts because a Guild member provides for the children affected through another program she is involved in. The Comfort Quilts will be mingled and housed by Denise Chase. Members may contact her when they know of a need. The causes receiving Comfort Quilts will remain the same. Denise will also have kits and fabric available at her house.

Membership Prize: Penny LaRochelle's number was drawn and she drew a \$25 gift card to Yankee Pride.

The meeting was adjourned on a motion by Bonnie Evans followed by "Show and Tell".


